- * Definition of Resident**

 - A non-citizen of Malaysia who has **obtained a permanent Resident status in Malaysia** and is **ordinarily residing in Malaysia**;
 - A **body corporate incorporated or established, or registered with/or, approved by any authority, in Malaysia**;
 - An **unincorporated body registered with or approved by any authority in Malaysia**; or
 - The **Government** or any **State Government**.
- ** Definition of Non-Resident**
 - Any person **other than a Resident**;
 - An **overseas branch, a subsidiary, regional office, sales office or representative office of a Resident company**;
 - Embassies, Consulates, High Commissions, supranational or international organisations;
 - A **citizen of Malaysia** who has obtained **permanent Resident** status in a country or a territory **outside Malaysia** and is **residing** outside Malaysia.

3. **Applicable only to Joint Accounts Holders**
