

PRODUCT DISCLOSURE SHEET for Auto Shield Insurance

IMPORTANT NOTE: Please read this Product Disclosure Sheet before you decide to take out the Auto Shield Insurance Policy. Be sure to also read the general terms and conditions.

What is this product about?

Section A covers the Insured, driver and/or passenger in the event of bodily injury due to accident resulted in death or disablement while driving or riding, boarding or alighting from the vehicle named in the policy

This policy also extends to cover the Insured (Policyholder) for 24 hours worldwide irrespective of whether the Insured is in the vehicle as named in the policy against death or permanent disablement caused by accidental, violent, external and visible means. If the Named Vehicle is registered under Association/Corporation/Company, the Named Vehicle owner as the Policyholder may nominate it's employee to be covered under this extended coverage.

Section B (optional benefits) are available for private vehicle owners should they wish to cover other benefits such as vehicle Spray Painting Expenses and Daily Inconvenience Allowance.

Note: Please refer to the brochure for benefit details on Section A and/or Section B.

Eligibility - Motor Comprehensive policyholders and their authorised drivers aged 17 years to 70 years old. Passengers aged 3 years up to 70 years old.

What are the covers / benefits provided?

Please refer to Table of Benefits in the product brochure.

Duration of cover is generally one year. You need to renew your cover annually unless you sign up an auto renewal payment instruction to renew automatically, subject to terms and conditions.

How much premium do I have to pay?

The premium that you have to pay may vary depending on plan selected. You may refer to the brochure for details.

What are the fees and charges I have to pay?

The fees and charges that you will have to pay are:

What are some of the key terms and conditions that I should be aware of?

Importance of Disclosure

- STATEMENT PURSUANT TO FINANCIAL SERVICES ACT 2013, Section 129, Schedule 9, Para 5: It is the duty of the customer to take reasonable care not to make a misrepresentation to the licenced insurer when answering any question which the insurer may request that are relevant to the decision of the insurer whether to accept the risk or not and the rates and terms to be applied.
- Special provisions (Section A)
 - In the event that the actual number of passengers exceeds the number stated in the policy schedule, the Company's limit of liability per person under Section A will be reduced by the ratio of the actual number of passengers to that of the number of passengers declared. The limitation shall not apply to the driver.
 - b) Passengers aged between 3 years to 15 years old are entitled to 50% of all the benefits under Section A.
- (iii) Passengers aged 3 years to 70 years old are covered.
- (iv) The driver must hold a valid driving licence and the territorial limit covered is Malaysia, the Republic of Singapore and Negara Brunei Darussalam.
- (v) Optional Benefits are claimable only in the event of a corresponding own damage accident on the named vehicle made against Insured's comprehensive private vehicle policy is payable by the Company.
- (vi) Compliance with policy conditions failure to comply with any of the policy conditions shall invalidate all claims.
- (vii) Two Or More Policies If at the time of any claim under Benefit Item 3 (Medical expenses, Corrective Dental and/or Cosmetic Surgery and/or Ambulance Fees) there shall be any other insurances covering the same risk whether with us or otherwise, we shall pay on reimbursement basis up to the limit of liability and shall not be liable for more than the balance of unpaid claims by other Insurers up to the benefit limit.
- (viii) Insured aged 17 years old and above but below the age of 18 years old must obtain parental/guardian consent before purchasing this insurance Policy.

6. What are the major exclusions under this policy?

This policy does not cover certain losses, such as:

- Pre-existing conditions and disease and sickness of any kind;
- Childbirth or miscarriage;
- If You or Your Authorised Driver is under the influence of alcohol or intoxicating liquor, narcotics, dangerous drugs or any other
 deleterious drugs or intoxicating substance to such an extent that You or Your Authorised Driver are incapable of having proper
 control of the Vehicle;
- While the vehicle is used for illegal activities or as an unlicenced carrier;
- Suicide and any attempt thereat;
- If You or Your Authorised Driver do not have a valid driving licence to drive the Vehicle. This will not apply if You or Your Authorised
 Driver have an expired licence but are not disqualified from holding or obtaining such driving licence under any existing laws, bylaws and regulations;
- Acquired Immune Deficiency Syndrome (AIDS) or AIDS Related Complex (ARC);
- Terrorism cover.

Note: This list is non-exhaustive. Please refer to the sample policy contract for the full list of exclusions under this policy.

7. Can I cancel my policy and how do I cancel it?

You may cancel your policy by giving 14 days written notice to AmGeneral. We will retain the premium according to the short period table for the period the policy has been in force and refund to you the unexpired portion of the policy period, provided no claim has been made during the period of insurance.

8. What do I need to do if there are changes to my contact details?

It is important that you inform us of any change in your contact details to ensure that all correspondences reach you in a timely manner.
